This research project had a triple focus: on news organizations, on journalists, and on the product of their work, news. Within this research endeavor, the challenges news organizations are facing and the drastic modifications they are undergoing in the light of convergence dynamics, were studied. At the same time, it was investigated how the tasks, roles, self-perception and professional cultures of journalists are (re)appropriated in the internet era. Thirdly, it was examined how the practices related to this new reality are reflected into the news product.

The analysis points to a restrictive, fragmented, decontextualised discourse, where critical elements of the crisis are omitted, and where the governmental and the troika's policies are legitimized by the media coverage of the bailout-related news, through a set of discursive mechanisms.
