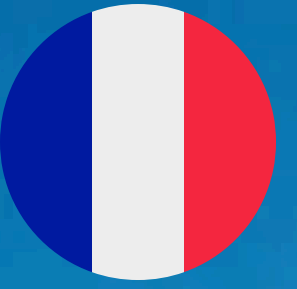

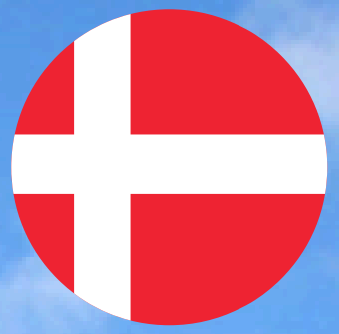

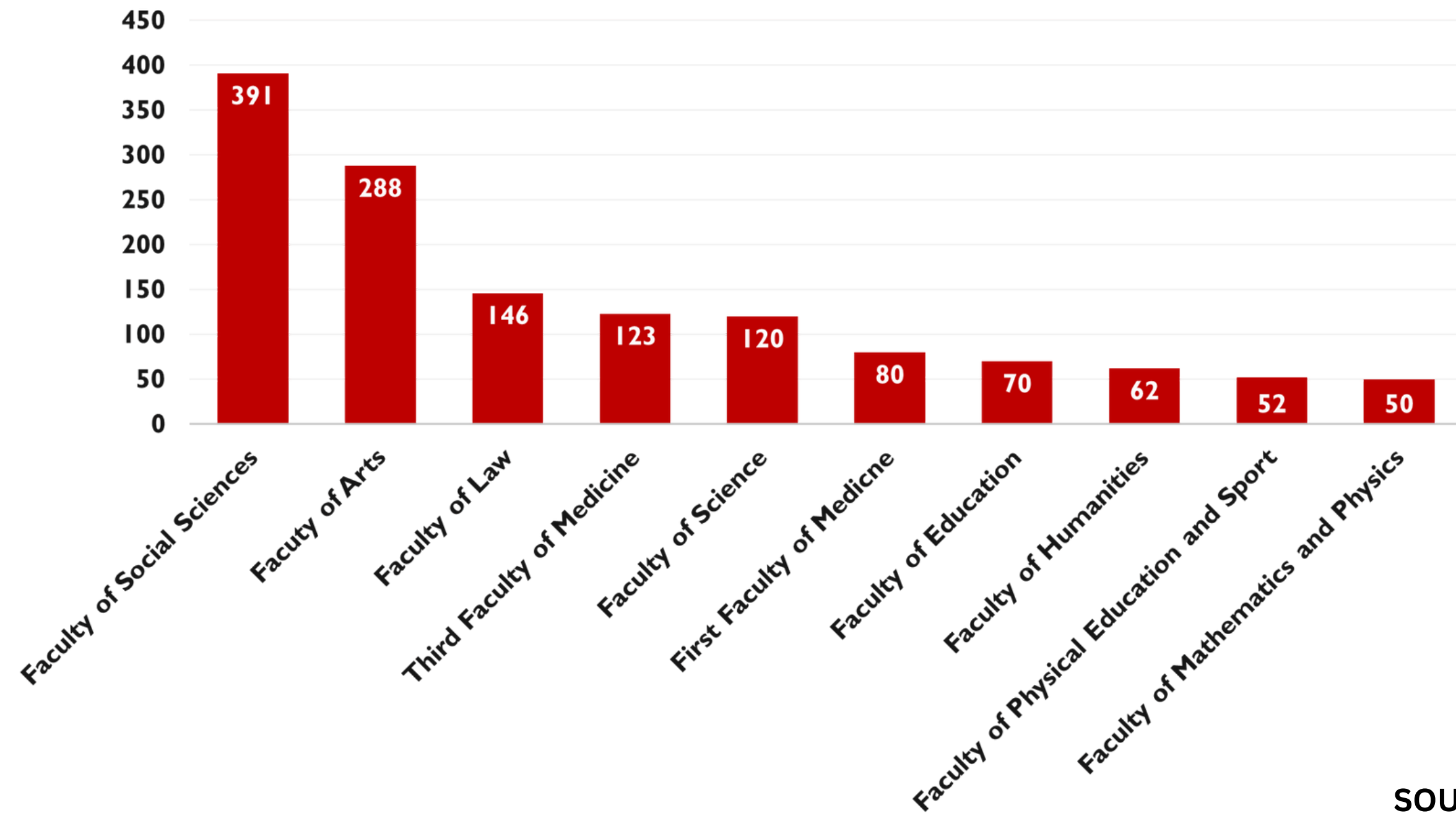

# **SCHOLARSHIP - SWITZERLAND**

For study stays under bilateral agreements  
with Swiss universities,  
students receive a scholarship of 350 euros/month  
from Charles University and 440 CHF contribution from the Swiss government.



## Green Erasmus

- The one-off contribution of EUR 50 for using an environmentally friendlier way of transport
- Eligible means of transport to / from the receiving foreign institution are **train, bus, boat or shared car.**
- The contribution is sent after the end of the mobility and after providing the European Office RUK the accounting document (tickets, proof of payment...)
- Must be specified in WebApps in advance
