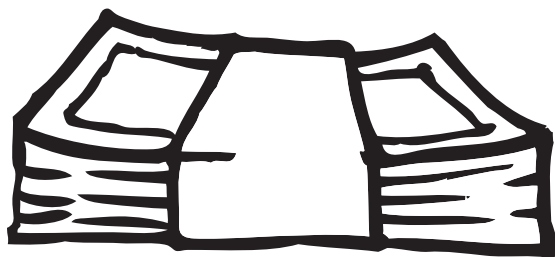



**What is the programme about?** BEF will give you a thorough grounding in both theoretical and applied economics and finance. Since we put an emphasis on developing abstract analytical reasoning, as a graduate you will be able to solve complex economic and financial problems in various settings. The courses are taught both by the members of the

Institute of Economic Studies (IES) and by external professionals from the financial industry.

**After graduation:** Our graduates usually continue to graduate level programmes like the MEF programme. You are also able to immediately start working in international, research, administrative or commercial environments.

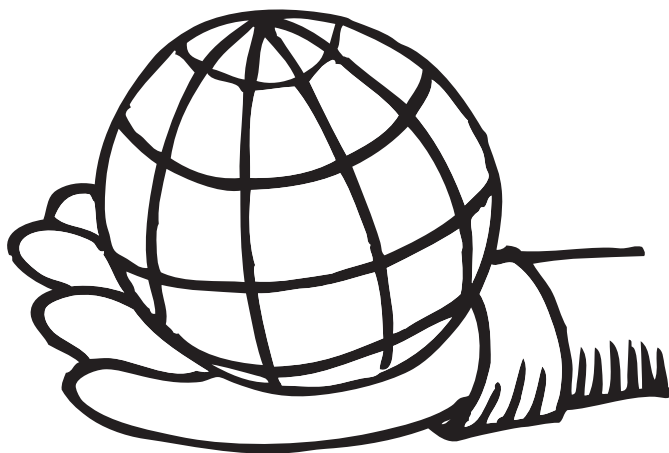

**What is the programme about?** This unique international double-degree programme with the University of Strasbourg will provide you with broad knowledge and understanding of economic theory with a focus on financial and international economics corresponding to the present state of the art. Upon the completion of studies, you will receive a Master's Diploma in "Corporate Strategy and Finance in Europe" from the University of Strasbourg and a Master's Degree Diploma with the academic title "Magistr" from Charles University.

**After graduation:** Graduates are qualified to undertake advanced-level quantitative analysis and modelling in economics and finance and are typically financial analysts, economists in corporations, consultants, economists in central banks and international organizations.

**What is the programme about?** This Bachelor's degree programme concentrates on modern history, culture and politics with respect to the Czech Republic in Central European and global context. It combines the education in history and area studies with an active training of the Czech language. It is organized and executed by the Institute of International Studies in cooperation with the Institute for Language and Preparatory Studies; hence it connects qualified modern history and area expertise with an excellent language preparation.

**After graduation:** You will be able to analyse individual topics arising within the Central European region in terms of modern history, political science, international relations, and culture. You understand current issues in their historical, societal, political, and cultural context. You will employ the languages as well as the acquired knowledge in an everyday use and develop and cultivate them in the continuing studies or in the professional field of the state administration, cultural institutions, NGOs or media.

## BALKAN, EURASIAN AND CENTRAL EUROPEAN STUDIES (BECES)

**What is the programme about?** This Master's degree programme focuses on modern history, politics and diplomacy, as well as on fundamental social, cultural and economic problems. It addresses the English-

speaking audience with its two specialisations (/1/ Russian and Eurasian Studies and /2/ Balkan and Central European Studies) a deep and versatile exploration of "the East", understood as a territory composed

of Central Europe, the Balkan Peninsula, and the Post–Soviet area, including the Caucasus and Central Asia. It also offers you the chance to learn or improve your knowledge of chosen regional language (e.q. Czech, German, Russian, Polish, Hungarian, Serbian/Croatian, Albanian, Greek, Romanian, Bulgarian).

**After graduation:** You will acquire an advanced level of graduate education including a good command of one or two languages of the area as well as

a broad and, at the same time, deep knowledge of the region studied. You will be capable of open but critical understanding and of conceptual thinking, and of appreciating cultural diversity. This intellectual equipment will provide you with an opportunity to continue your self-education and find positions related to the problems of the studied area in both public and private spheres.

**After graduation:** The programme graduates will become highly-skilled employees in the civil service and diplomacy, NGOs and international institutions as well as in private companies and mass-media. They will be well prepared for a variety of academic pursuits and will possess a wide range of knowledge and skills required in various social science fields.

In your first year you will study at the School of Slavonic and East European Studies, University College London (UCL), the coordinating university which is listed among the top twenty global universities, and you will spend your second year at Charles University.

**After graduation:** You will be well prepared for positions in distinguished private and public sector organisations or you can continue with doctoral studies.

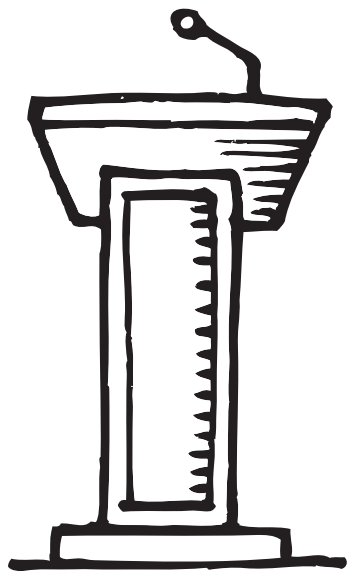

**What is the programme about?** EPS, a multidisciplinary two-year programme links the fields of European politics, contemporary history and culture, economy, international relations and policymaking. The key role of the programme is to identify and analyse challenges Europe faces today (migration, security, populism). The first semester of EPS is based on Master level introductory courses (in Prague); the second semester focuses on EU related courses (Krakow, Leiden). In the third and fourth semesters, the programme offers four different study tracks reflecting the diverse expertise of the Consortium members (Prague, Krakow, Barcelona, and Leiden). Each track combines various elective courses, research methods training, an internship and language tuition with an advanced research dissertation supervised by key staff from each Partner University.

**After graduation:** The programme gives you the possibility to acquire high-profile pluridisciplinary knowledge and skills. The first goal of the EPS is to prepare a new generation of managers, policymakers and research leaders. The excellence of the programme is based on a central focus on the societal, political, economic and cultural processes that have formed contemporary Europe and its role in the international environment.

**What is the programme about?** The programme is modelled on the Oxford-style “PPE” and aims to give you a solid grounding in political science (including international relations), philosophy (especially political philosophy and social ethics) and economics. The emphasis is placed on enabling you to learn to analyse complex social, political and economic issues in a multidisciplinary manner, looking at the problems to be solved from complementary perspectives. Since traditionally the PPE study programmes aim at educating civic, political and

business leaders, the study of philosophy is included in the curriculum to foster critical and creative thinking. PPE also stresses the importance of the ethical and global dimensions of the social, political and economic reality.

**After graduation:** The careers most commonly chosen by PPE graduates are in business management, public administration, banking and finance, politics, diplomacy and local government, social work, NGOs, journalism and broadcasting, education and publishing.

**What is the programme about?** The programme will deepen your understanding of various international security topics, including conflict resolution, security organisations, regional complexes, terrorism, peace-keeping, energy policy or human security. It respects the multidisciplinary dimension of contemporary

security studies but is firmly rooted in the international political aspects of the field. You will be introduced to the theoretical foundations and empirical realities of the discipline structured around the following modules: strategic and conflict studies, regional security, European and Transatlantic security and

security and technology. The courses cover a wide range of security issues associated with the traditional domains as well as reflecting new agendas dynamically evolving in the space or cyber realms.

**After graduation:** You will be prepared to pursue careers in security-related posts in government offices and public administration, international organizations, NGOs and transnational corporations.

The programme will help you appreciate how international and European politics work, and the challenges faced by states as well as business and societies in the globalized world. You will study how international conflicts can be productively

transformed into cooperation. You will develop your analytical capabilities, critical thinking, communication skills, and the ability to work with information.

**After graduation:** You become highly valued experts in national administrations and diplomatic services, European and international institutions, transnational corporations and NGOs, the media, think-tanks, political parties, and academia.

**What is the programme about?** The programme investigates contemporary political, economic and social issues from a multidisciplinary perspective akin to the PPE Oxford style. Although the emphasis

in IEPS is placed on economics and political science, you will also be expected to explore their historical, legal and sociological aspects. IEPS offers a unique study both in its contents and

methods of interactive learning, where you and instructors are partners to master the professional skills-building. It is based neither on an overview of facts about the social organisation, nor on crunching of abstract mathematical models – it aims to enhance the ways of critical thinking and understanding of social, economic and political phenomena in globalised societies. The programme offers a high flexibility in curricula where students

can choose from a portfolio of over 90 courses subject to their own specialisation.

**After graduation:** You will be expected to master the principles of modern non-conventional economic thinking and be able to apply them in political decision-making at the level of supra-national institutions, national and regional governments, financial corporations, firms, political parties and groups of citizens.

**What is the programme about?** A unique, multidisciplinary programme offers you a chance to learn from academic authorities and experts in this field. You will be encouraged to make connections between different fields of study, learning to combine a global perspective with attention to detail and local interests.

**After graduation:** GPS is an excellent stepping stone in developing an academic career in the field of Political Science, as well as a valuable source of analytical skills and practical background knowledge that can be applied in professional life. The programme is highly focused on employability – outside speakers will provide networking opportunities.

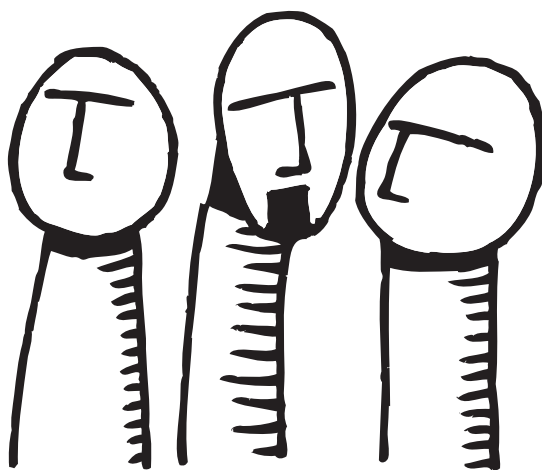
**Programme duration**

**What is the programme about?** IMSISS is a 24 month Erasmus Mundus Joint Master Degree developed by a consortium of three European universities – University of Glasgow (UK, leader), Dublin City University (Ireland, degree awarding partner) and Charles University (degree awarding partner). It is a unique interdisciplinary programme, funded with support from the European Commission, offering you a cutting-edge training in several relevant security areas.

You will examine a broad range of contemporary security challenges, such as terrorism, civil war and conflict, mass migration, energy supply security, cyber security and new technologies, and transnational and serious organised crime. You will also explore the intelligence and strategic approaches used by governmental and non-governmental actors to combat these threats.

**After graduation:** With the growing instability and rise of malign security phenomena you as a graduate can seek positions in the dynamic field within the state as well as non-state and private sectors. The former involve security-related posts in government offices and public administration, intelligence agencies, or international organizations while the latter include a wide range of opportunities in NGOs and private companies requesting highly relevant security expertise.

**What is the programme about?** A three-year English-language Bachelor's interdisciplinary programme aims to develop your analytical skills in social sciences. The main focus is on studying current issues and problems that are essentially transdisciplinary, such as complexity management, governance, mediatization of social relations or interdependence of society, technology and the natural environment. The second axis is social research methodology which is a prerequisite for the development of students' analytical skills and for finding practical solutions to complex issues.

**After graduation:** The emphasis on the final bachelor's thesis contributes not only to the development of soft skills (language, presentation, expression of thoughts) but also serves as a preparation for project-oriented research that dominates the current expert knowledge production. The structure of elective subjects corresponds to the field portfolio developed at FSV UK and enables you to profile according to your interest or with a view to your follow-up studies.

an international context. As a graduate you will have a chance to become an expert in concrete policy domains.

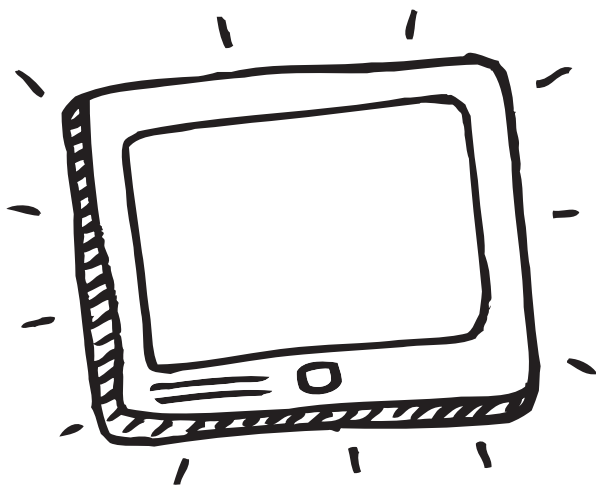

This will support your future employment in more senior/advisory positions in a variety of social fields and organizations, including state administrations, private sector, public service institutions, and non-profit organizations.

**We expect that applicant's level of English corresponds to at least the B2 level.** You don't have to provide any evidence of your English competence unless otherwise stated.



**Diplomas, transcripts and other documents** whose original language is not English, Czech or Slovak, have to be accompanied by a certified translation into English.

# ENTRY REQUIREMENTS

---

## All applications must include:

- Completed application form
- Copies of all relevant diplomas and transcripts: Copies of diplomas and transcripts do not have to be certified. However, if you submit uncertified copies, you must bring the originals of all submitted documents with you to Prague so that we can confirm their authenticity. If you have not yet finished your previous studies and thus do not have a diploma, please submit an official confirmation of studies including information on the expected date of graduation.
- Short academic curriculum vitae (resume) detailing all relevant qualifications and experience
- Letter of motivation

# REDUCING OR WAIVING THE FEE

---

## Merit-based discount

Several degree programmes offer reductions in school fees based on the students' academic achievements (students' GPA). Such reduction in school fees might be 1000 EUR or 2000 EUR per semester. Sum is paid out in November retrospectively for the previous academic year in the form of a one-time payment.
