



Visiting Professor in Macroeconomics and Finance

The Institute of Economic Studies of Faculty of Social Sciences, Charles University is looking to hire an associate or full **Visiting Professor in Macroeconomics and Finance** to carry on research activities on financial institutions, financial intermediation, financial regulation, household finance, or public finance.

This full-time position lasts **6 months**, beginning on **September 1**, **2018** and ending on **February 28**, **2019**. The gross (pre-tax) salary is in the range around 4,500 euro/month.

Visiting professor will become an active member of the economics and finance community at the Institute of Economic Studies, Faculty of Social Sciences, Charles University. In particular, visiting professor will contribute to improving our research profile by

- joint research in the field of macroeconomics and finance,
- organization of a workshop on main research topics of his or her interests,
- organization of two workshops aimed at research skills,
- participation in PhD seminars, while giving extensive feedback to Ph.D. students,
- consulting research agenda with junior faculty members in particular,
- and consulting management on the graduate programs.

The position is part of the implementation of a Charles University Project "International Mobility of Researchers at Charles University", reg. nmbr.: CZ.02.2.69/0.0/0.0/16_027/0008495, which is cofinanced from Operational Program Research, Development and Education (OP VVV).

Charles University currently ranks in global top 100 in Economics, top 200 in Finance (both ShanghaiRanking's Global Ranking of Academic Subjects 2017), and 104th in Economics and Business (the US News Global Ranking of Universities 2018). Each candidate must

- have a senior academic or research position in macroeconomics or finance, with his or her PhD defended before September 1, 2011,
- for at least 2 out of the last 3 years have resided at an institution outside the Czech Republic with a workload at least 50%,
- have at least three articles (indexed in Web of Science) published in the last five years,
- have served as a principal investigator or a co-investigator in an international or national research project in the last five years.

The preference will be given to candidates with a Scopus H-index of 7 or higher, and recent publications in highly recognized journals in macroeconomics and finance or in top journals in finance.

The application includes

- academic CV, including the full list of publications and a detailed description of academic or research position in the last 3 last years, and
- a scanned copy of Ph.D. diploma.
