# Criteria for Evaluating the Results Worthy of Remuneration from the Resources of the Coordinator within Progres Q18

## **Group 1 - Publications**

#### Scientific book

- 1) includes a research monograph of exceptional quality, which:
- a) publishes original and revealing results of scientific research of the author or team of authors:
- b) achieves a world class within a given field (renowned publishing house, min. 2 renowned reviewers);
- c) forms a very significant and demonstrable contribution to the development of the field (praiseful opinions of reviewers);
- d) is characterized by a very high methodological level and intensity of treatment.
- 2) includes a college textbook or a manual of exceptional quality, which:
- a) achieves a world class within a given field (renowned publishing house, renowned reviewers);
- b) forms a very significant and demonstrable contribution to the teaching of a given field (e.g., providing an authoritative textbook or manual for an important topic or discipline);
- c) is characterized by a very high educational level and intensity of treatment.

## Chapter in a scientific book

- 1) Includes a chapter in a research monograph of exceptionally high quality (see definition of book 1). No introduction or introductory word is considered a chapter in a professional book. The result of this type can be applied in the category of Editing of Professional Publication.
- 2) Includes a chapter in college textbook or manual of exceptionally high quality (see definition of book 2).

## Article in a scientific journal

It includes an original article published either in a journal impacted in Journal Citation Reports database or Scopus, or in a foreign journal recognized in a given field.

It does not include reviews, profiles, commentaries, editorials, obituaries, etc., or text below 10 standard pages, or 18,000 characters, including spaces.

# Editing of a scientific book or monothematic issue of a scientific journal

The edited publication has to meet the above mentioned qualitative specifications for a scientific book or a scientific journal. The rationale for the proposal must include a clear characteristic of the role of the proposer at the emergence of the result.

#### **Group 2 – scientific activities**

#### Certified methodology

The result certified methodology realized the original results of research and development, which were created by an author or a team of which the author was a member. It is a result where the author creates a methodology (the novelty of procedures is a necessary condition), which was approved and recommended for practical use by an appropriate state administration body or an expert certification body. The council of the Programme Q18 can ask for the whole version of the result to evaluate its quality.

#### Scientific teams

- 1) Formation and coordination of the activities of the scientific team within Progres with the participation of workplaces/faculties/ universities in the Czech Republic.
- 2) Formation of membership in a foreign scientific team researching a major scientific project.

The team is understood as a group of researchers and doctoral students (or postdoc) that works together in a clearly defined topic at least for two years that has a firm organizational structure and systematically reports specific research activities, mainly publications, but also other scientific activities. Publications can also be nominated separately as the results in group 1.

#### Research grants

Termination of the grant project with excellent results significant for scientific disciplines in the frame of program Progres Q18. A prerequisite for rewarding such an activity is that the project was completed under the duration of Progres Q18 and that the researcher or the head of the research team submits the evaluation made by the provider.

## **Conferences /workshops**

- 1) Performance as a keynote speaker at a major domestic or international conference.
- 2) Organizing a major international conference or workshop. A crucial part in the conceptual preparation and implementation of the event is a prerequisite for granting a reward or scholarship.
- 3) Creation and presidency of the panel at a major international conference.

#### **Guest lecture**

1) Hosted speech (lecture, presentation, etc.) at a foreign university.

#### Presentation of the outcomes of science in the public

- 1) Prestigious performance in public space as a representative in a given field. The most prestigious ones are such performances that, by their scope, traces, etc., make it possible to zoom the public into the field, show its main problems or the most important issues currently under discussion (e.g. Hyde Park Civilization, CS History and similar publications, documentary or popularization programs and radio and television bands).
- 2) Continuously and significant popularizing media outputs accompanied with an acknowledged affiliation to a faculty (not short commentaries on daily events), such as:
- a) specialized collaboration on the screenplay/documentary film/television show, periodically lectures on the radio:
- b) essay / extensive commentary in political, social and cultural magazines and revues:
- c) successful and long-term conduct of popularizing presentations in new media (websites, scientific blogs, specialized online videos, etc.).
