2. Purpose and Scope of the Measure

This measure issues a new updated version of the Directive - Pricing of paid programmes created directly for lifelong learning at FSV UK, based on Decree No. 450/2009 Coll., implementing Act No. 526/1990 Coll. on prices, as amended. It determines the price for participation in a specific programme designed directly for the purposes of CŽV at FSV UK unless the price is based, for example, on a cooperation agreement for a programme where FSV UK is a partner. In particular, this involves summer schools.

Part II – Basic Terms, Rules, and Roles

3. Definition of Terms

- 3.1. **Lifelong Learning (CŽV)** - within the framework of CŽV, FSV UK provides the possibility of education in bachelor's and master's degree programmes in the form of so-called study stays or participation in selected courses; it provides a large number of courses of the University of the Third Age, as well as several courses designed specifically for the purposes of CŽV intended for the general public. The pricing of these courses developed at FSV UK directly for the purposes of CŽV is determined by this Directive.
- 3.2. For the purposes of this Directive, **calculation** means price calculation according to Appendix No. 1 to the Decree No. 450/2009 Coll., implementing Act No. 526/1990 Coll. on prices, as amended.
- 3.3. For the purposes of this Directive, **the price** means the amount paid for participation in the programme expressed in CZK or EUR.
