2. Purpose and Scope of the Measure

This measure issues a new updated version of the Directive - Academic Calendar of the Academic Year of the Faculty of Social Sciences of Charles University, which defines the basic conditions of student enrolment and establishes the calendar of the academic year, especially the dates of the start of individual semesters, the holiday periods, the end of the academic year, and the dates of enrolment in courses. A dedicated version of the directive is issued for each academic year.

Part II – Basic Terms, Rules, and Roles

3. Definition of Terms

- 3.1. The academic year lasts 12 calendar months. Its beginning is determined by the Rector. The academic year is divided into winter semester, summer semester, and holidays. The Rector determines the beginning of the semesters and holidays. Both semesters are taught through lectures and seminars, the semester ends with an examination period with credits or examinations received in individual courses-
- 3.2. **The semester** is governed by the currently valid academic calendar issued by the Dean. Each semester is followed by an examination period, the length of which is determined by the Dean. Any unplanned changes in the learning part of the semester are determined by the Dean by a decree posted on the official notice board of the Faculty.
- 3.3. A study applicant becomes a **student** on the date of enrolment. Enrolment takes place at the faculty that implements the respective study programme within the time limit set by the Dean of that faculty. A person whose studies have been interrupted becomes a student on the date of re-enrolment. A person ceases to be a student on the date of termination of studies in accordance with § 55 para 1 and § 56 paras 1 and 2 or interruption of studies in accordance with § 54 of Act No. 111/1998 Coll., Act on Universities and on Amendments and Supplementations to Other Acts (the Act on Universities).
- 3.4. The Study Information System (SIS) is a centrally operated study information system for all faculties and other units of Charles University. The system serves students, lecturers, student services office, and other user groups. The web part of the system is intended primarily for students and teachers.

Part III - General Provisions

4. Enrolments of Students

- 4.1. Enrolment of newly admitted applicants takes place before the start of the academic year, according to the schedule of the student services office posted on the Faculty's website.
- 4.2. Current students enrol themselves in the 2nd and higher year of study once a year, according to the dates set out in this academic calendar, via SIS UK.
- 4.3. Students enrol in individual courses each semester, only through SIS UK and only during the period specified in this academic calendar.
- 4.4. Enrolment in the course on the date specified in the academic calendar is a prerequisite for the possibility to take the course.

- 5.1. Academic year starts on 1. 10. 2024 and finishes on 30. 9. 2025.
